Special Presentations

Sheriff Weaver distributed a handout to Board members showing the types and number of offenses in Highlands Ranch for the 2010 year (see addendum). He indicated that crime has decreased by 10% in Douglas County.

Phyllis Harvey spoke to Board members on Douglas County's efforts on suicide prevention. She distributed a handout describing suicide prevention and intervention resources, the Douglas County Suicide Prevention Alliance, suicide facts and risk factors (see addendum). The Youth Education Safety in Schools Program is very successful. The "Out of the Darkness Walk" will be held on September 10, 2011, during suicide prevention week, in Highlands Ranch. There will also be a fundraiser on April 30th to raise funds for students to attend therapy who do not carry health insurance. Phyllis invited participation in the Douglas County Suicide Prevention Alliance. Philip Cullen asked if the new sub-station will be a local resource for suicide prevention. Phyllis responded that in general the resources are on a more centralized basis across the state however the 211 assist call center provides access to local resources. Officers are also sent out to assist with any imminent threat of suicide.

Sheriff Weaver encouraged everyone to participate in the Emergency Notification Network by recording their cell phone numbers on the sheriff's web site for this program.

Rick Hopp spoke to Board members regarding a proposal to increase the size of AT&T cell phone antenna arrays attached to street lights to 24 inches. Board members agreed with the following conditions; location dependent, higher lease payments and Douglas County approval. The increased pole size requests will be reviewed by Board members on a case by case request.

Representatives from Douglas County gave a presentation to Board members on actual expenditures on transportation related improvements in 2010 and 2011 proposed transportation priority projects in Highlands Ranch (see addendum).

Public Comments or Questions

Boy Scouts from troops #633, #873 and #645 introduced themselves to Board members.

Nicole Cimbura spoke to Board members regarding the Fire and Emergency Study. She would like the study results to be released to the public for review. Board members and staff responded that the study will be considered for release only when negotiations have been concluded and a contract is signed.

Brent Hogan distributed photos to Board members showing a tree behind his home that he would like to have removed due to its inability to remain healthy and grow. He feels the tree is visually unappealing. Board members directed staff to conduct another assessment of the tree.

Board members discussed potential uses for the house, costs for needed repairs and maintenance, and relation to the renovation of the Mansion. Board members authorized staff to discuss transferring ownership of the Chum Howe House to the Metro District for limited uses if Douglas County is willing to help fund the necessary upgrades.

Rick Owens recommended that the boards discuss current topics. He asked Board members to send him suggestions for any additional agenda items.

The Board retreat will take place on June 18th. Mary Reed Wolf will be asked to facilitate the retreat. Meeting place is yet to be determined.

Board members would like to meet with the Douglas County Board of County Commissioners sometime in July. Terry Nolan will set up the meeting date and time.

Carolyn Schierholz requested an update on the status of a roundabout at the McArthur/WagonBox/Valleybrook intersection. Douglas County has previously indicated that the intersection does not meet warrants for a traffic signal. The Metro District has requested consideration of installation of a traffic signal rather than roundabout using Metro District funds. Douglas County has yet to respond to that request. Terry Nolan will contact Douglas County to expedite a response.
