# **STAFF PRESENTATIONS:**

Terry Nolan gave a presentation to Board members on Metro District medical benefits renewal for 2012 (see attachment). Board members agreed to keep the same base plan if the CWSD board agrees and cover the increase in insurance costs for 2012. They asked to receive a health benefit market comparison and benefits survey during the 2013 budget process.
