**GUEST PRESENTATIONS:**

- Art Griffith and Larry Warner gave a presentation to Board members updating them on the C-470 Corridor Coalition (see addendum). The Coalition was started in 2011 by the Douglas County Board of County Commissioners to develop and implement a solution to improve safety and mobility along the C-470 corridor. Allen Dreher participates with the Policy Committee and Jeff Case participates with the Technical Working Group. Three possible solutions were presented. The process is currently in the public input phase. Board members discussed timing for improvements and taxpayer involvement for funding. Allen encouraged board members to attend a listening session on June 27<sup>th</sup>.
- John Hendrick gave a presentation to Board members on the Chatfield Reservoir Reallocation Project (see addendum). This project will allow Centennial and other water providers in the area to store surface water, when it is available, for use when needed. Rick Owens asked if costs for this project will be passed on to constituents. Bruce Lebsack will provide cost analysis to the board next week. There will be public hearings held next week on this issue. John Hendrick asked for board member support on this project. Board members directed staff to prepare a resolution for vote at the June board meeting.

**STAFF PRESENTATIONS:**

- Bill Dailey gave a presentation to Board members on storm damage in Highlands Ranch from the June 7<sup>th</sup> storm (see addendum). The storm water system performed well during the storm. Financial impact will be shared when clean-up has been completed.

**DISCUSSION ITEMS:**

- Board members discussed installing a flag pole at the Mansion. Nick Robinson indicated that the Rotary Club has volunteered to donate funding for the flag pole. Staff will recommend a reasonable location on the Mansion property.
- Board members applauded staff for the work completed at the Mansion. They expressed an interest in supporting an appreciation event for staff.

- Carolyn Schierholz asked about the impact on educational and cultural events at the Mansion due to an increase on the number of group/wedding events that have to take place to fund the Mansion annually. Staff will respond with an update.
- Carolyn Schierholz discussed plans by the county to narrow the street she resides on to limit high vehicle speeds at the corner by her home. She indicated that the fire department is not in favor of narrowing the street due to the large fire trucks they use to reach residents. Board members asked staff to communicate with the county on this issue and update board members.
