Staff Presentations

Carrie Ward gave a presentation to Board members on Coventry Ridge HOA fence replacement (see addendum). She indicated that the Metro District has done some research to determine if the fence is the property of the HOA or the Metro District. The District believes the fence is the property of the HOA. Staff suggests offering a proposal to Coventry HOA similar to the proposal offered to the Golf Club HOA. Board members directed staff to continue to research for information on fence ownership and present any findings to the Board.

Carrie Ward gave a presentation to Board members on Highlands Ranch signs on C-470 (see addendum). Current conditions of the signs include; faded paint, broken plexiglass and broken foundations. Board members discussed various repair and replacement options. Board members directed staff to patch and paint the current signs and to work with stakeholders to develop a replacement plan with dates and bring that plan back to the Board.

Carrie Ward gave a presentation to Board members on hazard trees at Northridge Park (see addendum). Staff will be removing four trees around the playground and four trees at the Mountain Cloud Circle park entrance. The trees will be replaced with smaller ornamental trees that will be more appropriate for the site and minimize damage to park structures from roots and hazardous limbs.
