The annual amount of supplemental irrigation included in the water budget is 27 inches from the third week in April to the second week of October each year. The 27 inches is broken down per billing period and a detailed schedule can be requested beginning of April each calendar year. Irrigation water use above the allocated amount each billing period will be billed at higher rate tiers.

Additionally, no outdoor watering is allowed between 10 a.m. and 6 p.m. Rain sensors are required on all non-residential irrigation systems. Failure to follow any of the rules and regulations contained in Exhibit A and A-1 can result in violations and fines added to your water bill.
