Special Presentations

Under Sheriff Holly Nicholson-Kluth along with Jeff Von, Radio Technician for Douglas County Sheriff's department, updated the Board on two new possible sites for the Public Safety Communications Tower: Grace Presbyterian Church and another possible site off highway 85. Holly stated it can take up to six months to get all the necessary information on a possible site. Rick thanked Holly and everyone who has been working on this tower for their transparency, dedication and thoughtful consideration in choosing a site that will meet the final goal which is to provide the best communications in Highlands Ranch.

Chief Armstrong from Littleton Fire and Rescue gave the Board a status report on:

- Public education events
- ISO evaluation will be in mid-November
- LFR has reviewed the Phase II draft of the ESCI study
- Quick Car trial program update

The Quick Cars are Tahoes equipped with everything an ambulance has, but without customer/patient transportation capabilities. These Quick Cars are improving service delivery and response times while saving costs and freeing the larger apparatus to be available for higher priority calls. Along with the Quick Car program, the Care Car is planning to be introduced, offering a 3rd alternative to the customer/patient. The Care Car offers the customer/patient a physician's assistant to come to their home for follow-up care thus providing them an alternative to transportation and emergency room costs.

Rick Owens thanked Chief Armstrong for LFR's transparency, their contributions to the 4th of July celebration and their commitment to continuous improvements of their services to the community.
