Chief Armstrong gave a Littleton Fire Rescue quarterly update covering:

1. Improved response times of 9 minutes 19 seconds

- 2. New recruits will have completed the academy and training and be ready to start in late September which should allow for the Medic 14 peak-hour unit to be put into service by the end of the year.
- 3. Chief Armstrong thanked the Board for their support in moving forward with an Intergovernmental Agreement (IGA) for dispatch service. A few key points regarding the IGA:
 - a. The current partners' agreement will need to be updated with language regarding dispatch services to match the contracted service agreement.
 - b. The first reading of the proposed dispatch services IGA in front of the Littleton City Council will be June 6^{th} .
 - c. No date has been set for a second reading.
 - d. Anticipated transition date of dispatch services is August 1, 2017.
- 4. LFR is currently working on the 2018 budget which will be brought before the Review Committee first.

A list of Metro District's South Metro Fire Rescue unification proposal needs was given to Chief Armstrong for a revised proposal. (*Addendum 1*)
