4. Guest Presentations

a) Mile High Flood District Update – Laura Kroeger, Executive Director

Laura gave a high-level overview of what the Mile High Flood District (MHFD) does and the priorities of their organization: safety, the community, stewardship and learning. She shared a district boundary map saying they serve 7 counties and 33 incorporated entities. MHFD has a variety of responsibilities including identification and mapping of floodplains, preparing planning studies, working with development on smart development, and purchase flood prone properties. They also design, construct and maintain improvements that provide the highest function and lower maintenance based on the site and community context. Education is really what put them on the map starting with urban stormwater criteria and their flood warning system. She shared that MHFD's partnership goals are to reduce flood risks with cost effective and safe public infrastructure while promoting healthy streams and recreation to support active and healthy lifestyles and educational opportunities.

Director Schierholz asked Laura as Denver Water proceeds with transfer of the Highline Canal did she think that was going to put more work on her organization? Laura said that what Denver Water's interest was more about water quality than stormwater infrastructure so from a dollars standpoint it is really hard for MHFD to justify involvement but from a partnership standpoint they want to be at the table because they do feel like they offer some expertise so they are part of the planning studies to see where there might be some flood risk issues and can participate at a dollar level that aligns with their priorities and they will also be helping with managing maintenance. Director Schierholz also asked about the older cottonwood trees and what happens if they start falling down or if they get flooded out, would that be something that MHFD could help out with, or would our staff have to address? Laura said this would be something potentially our staff would have to address however, Denver Water has set aside funds to assist with this process prior to the transfer.

The board thanked Laura for her time and for her presentation.

13. Special Reports

a) District Staff

General Manager Stanley reminded the board that the legislative special session began this week, so she is monitoring the property tax legislation currently being heard. It has been read in the House and once it moves through the House it will go to the Senate. It has support from both sides of the aisle. Stephanie had several calls with other Special Districts in Colorado discussing concerns and trying to document potential lost revenue as it relates to the proposed property tax measure. It is a reduction in the residential assessment rate so that would have a significant impact our revenue. As it moves through, there may be amendments so she will keep the board updated as she learns more but this, but it will probably pass. Director Jones inquired about the impact this could have to which the Director of Finance and Administration Zach Cartaya answered and said he was working with legal counsel on this.

Vice Chair Dickerson asked if there is potential in the future to increase the mill levy if the residential assessment rate lowers to allow revenues not to decrease. General Manager Stanley said at this time the way the bill is written we would not be allowed to increase the mill levy.

General Manager Stanley also reminded the board that Pioneer Days was coming up in early September and wanted to extend an invitation to the board.

She also reminded the board of the Toepfer Park Playground Renovation Open House that we will be hosting this Thursday at the park from 5-7:00 pm.

Director Jones asked her how word was getting out to which he was told through social media and our website as well as signs at the park. Director Jones asked Community Relations Manager Sherry Eppers if she had flyers that he could pass out to his neighbors and was told we didn't but that she would email him information tomorrow that he could share.
